II. PURPOSE

Sreenidhi International School recognizes the value of personal devices in enriching learning experiences and promoting innovation. This policy establishes clear guidelines for the responsible, ethical, and secure use of personal devices within the school environment to ensure they contribute meaningfully to holistic learning, creativity, and student agency, in line with the school's mission.

III. SCOPE

This policy applies to:

- All students (Kindergarten-Grade 12) and staff who bring personal devices to campus.
- All personal laptops, tablets, smartphones, or other connected devices used for academic or administrative purposes.
- All personal devices connected to the school's Wi-Fi or network.

School-owned devices are covered under a separate policy.

IV. GUIDING PRINCIPLES

The use of personal devices at Sreenidhi International School should reflect the school's commitment to:

- 1. Learning-Centered Innovation Devices should be used to support inquiry, creativity, and meaningful learning.
- 2. Respect and Responsibility Users are expected to demonstrate digital integrity and respect for others.
- 3. Student Agency Technology should empower students to express their voice, make informed choices, and take ownership of learning.
- 4. Digital Wellbeing Balanced, mindful, and healthy use of devices is encouraged at all times.
- 5. International Mindedness Technology should be used to connect with and appreciate diverse global perspectives.

V. ACCEPTABLE USE FOR STUDENTS

1. Purposeful Learning

Personal devices should be used to:

- a. Access school-approved platforms (e.g., Google Workspace, ManageBac, Turnitin, or educational apps).
- b. Conduct research, create projects, collaborate with peers, and communicate with teachers.

c. Demonstrate innovation and ownership of learning through digital tools.

2. Device Access and Network Use

- a. Personal devices must connect only through the school's Wi-Fi network.
- b. The use of VPNs, proxies, or tethering is strictly prohibited. VPN-installed device will be confiscated. NO EXCEPTIONS.
- c. Use of the OPERA browser is <u>strictly prohibited</u>.
- d. All devices must have up-to-date antivirus protection and be free of malicious software.

3. Prohibited Use

Students should not use personal devices to:

- a. Access or distribute inappropriate, explicit, or discriminatory content.
- b. Engage in cyberbullying, harassment, or online misconduct.
- c. Record, photograph, or share any images, videos, or audio of students or staff without prior consent.
- d. Stream entertainment, play games, or access social media during class hours, unless approved by a teacher.
- e. Download or share copyrighted or illegal material.

4. Responsibility and Care

- a. Students are solely responsible for the security, maintenance, and safe handling of their personal devices.
- b. The school is not liable for damage, loss, or theft of any personal device.
- c. Devices should be fully charged before arrival at school. Charging in classrooms is discouraged unless permitted.
- d. Students must not lend their devices to others.

VI. ACCEPTABLE USE FOR TEACHERS AND STAFF

1. Professional Use

Teachers and staff using personal devices must:

- a. Use them primarily for lesson preparation, instruction, assessment, and communication.
- b. Model ethical and balanced technology use for students.
- c. Access only school-approved applications and systems (e.g., email, ManageBac, Toddle, Turnitin).
- d. Teachers and staff are solely responsible for the security, maintenance, and safe handling of their personal devices. The school is not liable for damage, loss, or theft of any personal device.

2. Data Privacy and Protection

- a. Ensure student information and academic records are stored securely.
- b. Avoid storing or transmitting school data via personal email accounts or unapproved cloud services.
- c. Use the school's secure Wi-Fi and adhere to data protection regulations.

3. Network Use

- a. Personal devices must not be used to modify, bypass, or interfere with the school's network.
- b. The use of VPNs, proxies, or tethering is strictly prohibited. VPN Installed devices will be confiscated. NO EXCEPTIONS.
- c. Use of the OPERA browser is strictly prohibited.
- d. Streaming or downloading large non-academic files should be avoided to maintain network efficiency.

VII. NETWORK AND INTERNET SECURITY

- a. The school provides filtered and monitored internet access to maintain a safe digital environment.
- b. All users must respect the network's limitations and refrain from activities that disrupt connectivity or compromise security.
- c. The IT Department reserves the right to restrict or disconnect devices that pose a security threat to a network or violate policy guidelines.

VIII. DIGITAL CITIZENSHIP AND WELLBEING

Sreenidhi International School promotes ethical and globally responsible technology use. All users should:

- a. Engage respectfully and inclusively in all online communications.
- b. Credit original sources and avoid plagiarism.
- c. Maintain digital balance, ensuring screen time supports wellbeing.
- d. Report cyberbullying, misuse, or security issues to a teacher, IB Coordinator or IT Team immediately.

IX. CONSEQUENCE OF MISUSE

Failure to follow this policy may result in:

- a. Verbal or written warning
- b. Temporary or permanent loss of device/network privileges
- c. Parental notification

- d. Confiscation of the personal device during school hours
- e. Disciplinary action in accordance with the school's Behaviour and Academic Integrity Policies

X. EDUCATION AND SUPPORT

Sreenidhi is committed to guiding its community toward responsible digital practices through:

- a. Workshops on digital literacy, wellbeing, and cyber safety
- b. Curriculum integration of digital citizenship education
- c. Ongoing teacher and parent engagement on responsible device use

XI. REVIEW AND ACCOUNTABILITY

This policy will be reviewed annually by the IT Team and the School and Academic Leadership Team to reflect changes in technology, curriculum, and community needs.

XII. ACKNOWLEDGEMENT

STUDENTS MUST TAKE COMPLETE OWNERSHIP OF THEIR DEVICE. ANY DAMAGE OR LOSS WILL BE THEIR SOLE RESPONSIBILITY.
